Exposure to UV radiation from direct sunlight can play havoc with your inventory. 3M™ Protective UV tapes provide excellent abrasion resistance and solid protection from the harsh effects of the sun – up to 5 months for the clear film and 3 months* for the blue film. With dual protection from sunlight in both the film backing and the adhesive system, 3M™ Protective UV tapes shield effectively and remove cleanly even after prolonged UV exposure.

Applied during production, 3M™ Protective UV tapes shield your architectural building panels against surface damage and exposure to sunlight in transit and storage. 3M™ Protective UV tapes are available in two colours, clear and translucent blue. The blue film delivers the added advantage of being readily detectable on glass surfaces. Both versions allow for visible inspection of surfaces under the tape.


